#### Diploma Program

Grades will be released on **December 7**, **2023** for those that wrote the November exam. Grades will be posted to MY STEP accounts under "My Courses & Marks", and an announcement will be posted to the course website once marks are available.

Students who wish to register for the next course prior to receiving their course grade may do a **provisional registration**. The provisional registration form can be found on the course platform under General Forms. The completed form can be emailed to <u>education@step.ca</u>.

**Did you hear?** STEP Canada is updating the *Taxation of Trusts and Estates* course, which will launch for the Spring 2024 term. The new tax course offers a comprehensive education that lays a strong foundation in tax principles before engaging with the more detailed technical aspects. There will be enhanced learning opportunities such as knowledge checks, practice cases, and a graded assignment to test your understanding. Registration is now open and course materials will be available in January 2024.
