
An increasing number of STEP Canada members are encountering clients in vulnerable situations, including those who are unduly influenced or are at risk of financial, physical, or psychological harm.

**RE: Submission relating to the application of the Alternative Minimum Tax (AMT)** 

The Society of Trust and Estate Practitioners (Canada) sent a submission to Finance Canada on Friday, September 8, 2023 in response to legislative proposals pertaining to the alternative minimum tax (AMT) released on August 4, 2023, and the accompanying explanatory notes (collectively, "Proposals").

## **NEW - Taxation of Trusts & Estates Course**

The education team at STEP Canada is pleased to announce the launch of our **NEW** Taxation of Trusts & Estates course as of January 1, 2024. The new tax course offers a comprehensive education that lays a strong foundation in tax principles before students engage with the technical aspects of trust and estate taxation.

#### The new tax course will include:

- · A solid foundation of introductory tax concepts,
- plenty of opportunities for application (knowledge checks and practice cases for each chapter),
- expanded evaluation criteria (graded assignment, marked before the exam.),
- two collaborative peer learning sessions,
- · access to topic-based student discussion board,
- an interactive instructor-led case tutorial, and
- 4 weeks of access to the Instructor Q&A discussion board.

For students registered into the Taxation of Trusts & Estates course for the November 2023 exam: There is an option for students that defer the November 2023 tax exam to transfer into the new course without a new registration fee (usual deferral fees still apply, where applicable). The transfer will be available only if the deferral is made before the exam on November 6, 2023. Detailed information is posted inside of the tax course website. A reminder that deferrals made with less than 30 days' notice before the exam incur a fee.
