FEF is excited to share the results of our latest research on the transition intentions of Canadian business families in **Who are the Guardians of Family Legacy?** with members of STEP Canada. The research identified a generational shift that challenges the notion that the next generation is not ready, willing or interested in taking over the family business. In fact, 97 per cent of next gen respondents (18-35 year-olds) consider it important to sustain the family business. This is good news, as the next generation clearly have a passion to preserve the "familiness" of the business.


### **STEP Inside**
