About CETA

The Certificate in Estate and Trust Administration (CETA) program is designed to enhance the knowledge and performance of Canadian estate administrators, trust officers, junior trust officers, retail bankers, law clerks, junior associates, paralegals, wealth management sales representatives, and administrative assistants working in the area of estates and trusts. The CETA program sets an industry standard as the preferred educational offering for major Canadian trust institutions, providing benchmark professional development. Candidates who have a successful post-secondary education and/or one-year of wealth industry work experience are eligible to enrol.

CETA will be of value to individuals who want to advance their careers, and to employers who want to avail themselves of the many business opportunities resulting from today's shifting demographics. Organizations staffed by knowledgeable estate administrators and trust officers who can skillfully manage this changing market will attract new opportunities and clients.

The online self-study CETA program consists of three courses and exams, as well as a final cumulative certification exam. The program includes tutorial support, self-assessment quizzes, and social media networking. Students are expected to complete the program within four years, and achieve a minimum grade of 60 percent.

Single-course registration is available for the foundational curriculum (CETA 1) only. Courses must be taken sequentially if progressing beyond CETA 1. Students who complete the foundational course and do not plan to continue on with the rest of the program will receive a STEP Canada document of course completion.

Students enrolled in CETA 2 through 4 will receive full STEP Canada affiliate member benefits, and upon completion, the STEP Canada certificate in Estate and Trust Administration. CETA holders may choose to remain affiliate members, or continue with the four* courses of the STEP Canada Diploma Program, culminating in the globally-recognized Trust and Estate Practitioner (TEP) designation. This innovative program is available in English for common law and French for civil law.

*CETA certificate holders are exempt from course three in the STEP Canada Diploma Program: Wills, Trust and Estate Administration.
