What you'll do

Reporting to the Director, Gift & Estate Planning, as the Associate Director, Legacy, you will proactively enhance the growth of legacy commitments to the Foundation. Working closely with the Director, you will contribute to strategy development, fulfill the program vision, and bring creative thought to effect breadth and depth to the program's impact for current and future revenue. You will strategically and creatively consider prospect pools and implement steps to engage groups and individuals toward a confirmed legacy gift. In this role, you will execute personalized gift planning and deepen relationships with legacy prospects and members of the Legacy Circle to solidify enduring commitment to the Foundation and Hospital.

As the Associate Director, you will supervise a small but mighty team who conducts legacy prospect activities to attract inquiries and confirmations, as well as records and data integrity for the legacy pipeline. You will be highly collaborative with other team members who coordinate materials and will ensure donor facing initiatives remain fresh and reflect relevant information to educate and engage donors and prospects and contribute to stewardship plans.

Additionally, you will collaborate to provide nurturing and capable leadership with an emphasis on building gift planning capacity and results for all colleagues across the Foundation and exemplifies proven experience and subject matter knowledge for a variety of gift planning options suitable for a broad range of donor sophistication.

More specifically, you will:

- Lead with curiosity and a passion for the right personalized donor strategy to build trusting relationships and, uncover interests, needs and family dynamics for all legacy prospects and donors in all curated gift planning activities.
- Lead and manage strategies for mass inquiry pools, measure effectiveness, and suggest tactical
 adjustments. Assess and recommend tactics to increase the legacy pipeline and ensure a consistent
 messaging continuum to encourage decisions. Implement feedback collaboratively and assist the Director
 with budget planning.
- Collaborate with peers to ensure digital acquisition opportunities are maximized and lead the G&EP team's interests and needs with other Foundation teams (Information Technology and Data + Analytics).
- Deepen relationships with select Legacy Circle members; assume responsibility for a select group.
 Oversee welcome packages and lead onboarding options and avenues to best fit the donor journey.
- Implement and manage the gift planning staging system, regularly assess, and collaborate with the Manager and Prospect Development team to inform individual donor strategies toward legacy commitment. Personally manage select inquiries to enhance their journey toward legacy commitment. Demonstrate gift planning expertise in donor interactions.

 planning knowledge and confidence for cross team ability to secure legacy gifts as well as facilitate noncash gift types. Contribute as an experienced gift planner in the marketplace.
 - Develop relationships with advisors and maintain pathways for mutual benefit; contribute to the team's efforts to build a strong advisor network. Proactively monitor and suggest tactical improvements for data integrity for this group of relationships.

 - Contributing to program growth, developing business plans, and conducting results-driven evaluations.
 - Selecting and measuring mass records in a complicated, multi-user database system.
 - Curating the legacy donor's journey from interest to commitment, both personalized and group engagement.
- Experience managing, coaching, and mentoring people to ensure that they reach their full potential and excel in their roles.
- Advanced understanding of intermediate gift planning options, and sound familiarity or practical experience with advanced gift planning tools.
- Ability to navigate gift planning conversations with professional ease and warmth to ensure donor comfort and confidence to explore facets of gift planning
- Skilled verbal and written communicator to enhance donor experiences, impressions, and understanding in an inspirational way for both communication formats
- Ability to assess program impact from both an individual donor's perspective and as members of a broader group.
- Proficient in analyzing data indicators both collectively and individually, and translating insights into actionable solutions within a collaborative problem-solving framework.
- Engaging and collaborative team player adept at nurturing relationships with internal and external partners, demonstrating values-driven leadership.
- Strong knowledge and experience using databases; Raiser's Edge NXT is an asset.
- A class 5 driver's license and access to reliable transportation.
- A flexible schedule that allows for after-hours events and meetings.
